

Sourceability Electronica 2020 Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR:

This Sourceability Electronica 2020 Sweepstakes (the "**Sweepstakes**"), as more fully described below, is provided and sponsored by Sourceability North America, LLC (the "**Sponsor**" or "**Sourceability**").

HOW TO ENTER:

To participate in the Sweepstakes, participants must (i) first provide their contact information (first name, last name, email address, job title and company name) and schedule a demo with one of the Sponsor's business developers, including participants who scheduled a demo with Sourceability prior to November 9, 2020, and (ii) attend and complete the scheduled demo at the applicable time during the Sweepstakes Period (as defined below). Once a participant has completed the scheduled demo during the Sweepstakes Period the participant will be entered in the Sweepstakes. Participants do not need to attend the Electronica 2020 event to participate in the Sweepstakes. Because a demo must be done with a Sourceability business developer staff member the number of available time slots to schedule a demo is limited.

In addition, an eligible person may participate in the Sweepstakes by requesting an alternative entry form by sending Sponsor a self-addressed stamped envelope to Sourceability Electronica 2020 Sweepstakes, Alternative Entry Request, 2007 NW 84th Avenue, Doral, FL 33122 U.S.A. Once received the alternative entry form must be completed and returned before the end of the Sweepstakes Period to Sourceability Electronica 2020 Sweepstakes, Alternative Entry Submission, 2007 NW 84th Avenue, Doral, FL 33122 U.S.A.

Each participant is limited to one entry for the Sweepstakes. Multiple entries from the same participant and any fake entries by any participant will be disqualified.

ELIGIBILITY:

The Sweepstakes is open only to legal residents of the United States of America, other countries located in North America (except for the Quebec province of Canada), and the countries located in South America, Europe and Asia, in each case who are 18 years of age or older at the time of entry. The Sponsor reserves the right to require proof of age and other eligibility from any participant.

Excluded from eligibility are officers, directors, employees, agents and representatives of Sourceability and its affiliated companies, as well as relatives and persons living in the same household as any of the foregoing (collectively, the "**Excluded Individuals**").

NO PURCHASE IS NECESSARY TO ENTER THE SWEEPSTAKES AND A PURCHASE WILL NOT INCREASE A PARTICIPANT'S ODDS OF WINNING A PRIZE. THE SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

ACCEPTANCE OF RULES:

Participation in the Sweepstakes constitutes a participant's full and unconditional agreement to these Official Rules (the "**Rules**"), as may be amended by Sourceability at its sole discretion from time to time. Winning a prize is contingent upon a winning participant also fulfilling all requirements set forth in these Rules.

Notwithstanding any other provision contained in these Rules, Sourceability reserves the right, in its sole discretion, to modify, amend, cancel, suspend, reinstate or close the Sweepstakes, at any time in whole or in part without prior notification, and for any reason whatsoever.

SWEEPSTAKES PERIOD:

The Sweepstakes shall commence at 5 p.m. (PST) November 8, 2020 and shall conclude at 11:59 p.m. (PST) on November 12, 2020 (the "**Sweepstakes Period**").

PRIZES AND PRIZE VALUE:

Prizes will be provided by Sourceability and will be awarded in accordance with these Rules. Prizes for the Sweepstakes shall consist of four (4) Amazon gift cards each in the amount of US \$500, for a total estimated retail value for all prizes awarded of US \$2,000.

SELECTION OF WINNERS AND ODDS OF WINNING:

Winners (the "**Prize Winners**") for the Sweepstakes will be selected by random drawings from among all then eligible participants (including any participants by alternative entry) through the Sweepstakes Period, which drawing is scheduled to occur at or about 10 a.m. (CET) on November 16, 2020. The odds of winning a prize in the Sweepstakes will depend on the number of eligible entries received up to the time of the random drawings. There is a limit of one (1) prize per participant for the Sweepstakes.

NOTIFICATION OF WINNERS:

The Sponsor will attempt to notify Prize Winners by email. If after exercising reasonable efforts, Sourceability cannot reach a Prize Winner within fourteen (14) days after the end of the Sweepstakes Period, Sourceability will be free of any liability for awarding a given prize to that Prize Winner, and such prize may be considered by the Sponsor to be forfeited for all purposes by the applicable Prize Winner and Sourceability may choose another eligible participant's entry for the applicable prize.

TERMS OF PRIZE ACCEPTANCE:

Each prize must be accepted as awarded and may not be redeemed for cash. No substitution, assignment or transfer of prizes is permitted, except: (i) as otherwise explicitly provided herein; or (ii) at Sourceability's sole discretion. Sourceability reserves the right to substitute a prize with one (1) of comparable or greater value without liability or consent. Sourceability is not responsible for lost or misused prizes or promotional item. Sourceability will pay all shipping and handling costs associated with delivery of a prize to a Prize Winner. All other costs and expenses associated with a prize and not specifically addressed above, and any taxes thereon, are the sole responsibility of each Prize Winner.

PRIVACY MATTERS:

The personal information provided by participants may be used as provided in Sponsor's privacy policy or these Official Rules. See Sponsor's privacy policy (the "**Privacy Policy**") at <https://sourceability.com/privacy-policy> for details regarding use of the personal information collected in connection with the Sweepstakes. In the event of any conflict between these Official Rules and such privacy policy, these Official Rules shall control.

By entering the Sweepstakes, you grant Sponsor permission to correspond with you via email or social media regarding the Sweepstakes, to share your email address and any other personally identifiable information with any participating entities or third parties for the purpose of Sweepstakes administration, communication and fulfillment or for any other purposes permitted

by these Official Rules or the Privacy Policy. By entering the Sweepstakes, participants also are providing their consent to having their name and country of residence posted on the websites of Sponsor and its affiliates.

In addition, if you opt in to receive additional information from Sponsor as a result of a demo or otherwise, Sponsor may send you promotional e-mails, materials and reminders about Sponsor products and services. **PLEASE NOTE: AGREEING TO RECEIVE FUTURE E-MAIL UPDATES OR OTHER COMMUNICATIONS WILL NOT INCREASE CHANCES OF WINNING IN THE SWEEPSTAKES.**

Sponsor will not sell, rent, transfer or otherwise disclose your personally identifiable information to any third party other than as permitted by these Official Rules or the Privacy Policy.

ADDITIONAL TERMS:

Sourceability reserves the right, at its sole discretion, to disqualify any participant from the Sweepstakes if Sourceability finds or reasonably believes such individual to be tampering with the entry process or the operation of the Sweepstakes or where applicable, the Sweepstakes Page; and/or to be acting: (i) in violation of these Rules; (ii) in an unsportsmanlike or disruptive manner; or (iii) with the intent to annoy, abuse, threaten or harass Sourceability, or any of their respective employees, any other Sweepstakes participants, or any other person. Any attempt by a participant or other individual to automate the entry process, or to otherwise undermine the legitimate administration, security or operation of the Sweepstakes is prohibited and may be a violation of applicable criminal and civil laws. Sourceability reserves the right to seek remedies and damages from any such person to the fullest extent permitted by law. Participants engaging in any of the foregoing activities may be disqualified and will forfeit any prizes awarded to such participant.

Sponsor reserves the right to change the requirements for the Sweepstakes, including these Official Rules, if unforeseen circumstances or circumstances beyond Sponsor's control justify such changes, as determined by Sponsor in its sole discretion. In addition, Sponsor shall not be liable if, due to circumstances beyond its control, the Sweepstakes should be interrupted, postponed or cancelled. If any provision of these Official Rules is found to be unenforceable such provision shall be severed and the remainder of these Official Rules shall continue in effect.

The decisions of Sourceability in regards to all matters of the Sweepstakes are final and binding upon participants. In the event of any dispute regarding the interpretation of these Rules for the Sweepstakes or any decision rendered by Sourceability, the decision or interpretation of Sourceability shall prevail.

All participants must comply with all applicable laws.

RELEASES AND LIMITATIONS:

BY PARTICIPATING IN THE SWEEPSTAKES, EACH PARTICIPANT HEREBY RELEASES AND HOLDS HARMLESS ALL OF THE RELEASEES FROM ANY AND ALL LIABILITY, INJURIES, LOSS, CLAIMS OR DAMAGE OF ANY KIND WHATSOEVER (INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES) ARISING FROM OR IN CONNECTION WITH: (I) PARTICIPATING IN THE SWEEPSTAKES; AND/OR (II) ACCEPTANCE, USE, MISUSE OR NONUSE OF ANY PRIZE OR PARTS THEREOF, INCLUDING, WITHOUT LIMITATION, LIABILITY FOR DAMAGE OR LOSS OF ANY KIND, AND FROM LIABILITY TO ANY OTHER PERSONS RELATING TO OR RESULTING FROM ENTERING THE SWEEPSTAKES' PROVIDED THAT THE FOREGOING SHALL NOT EXCLUDE LIABILITY FOR BODILY INJURY OR DEATH.

GOVERNING LAW:
